ARGUMENTATION OF CHOICE OF THE STUDIO

Public buildings, besides providing various functions, also provide a place for encouraging social interactions between different target groups in an area, which is usually lacking in private buildings. This flexible handling of architecture is important for social interests.

It uses terms such as multiplicity, hybridity, resilience, and sustainability, it generates a public condenser that can be considered a social catalyst, it acts as a place of inclusion and diversity where different demographics, ethnicities, cultures, and lifestyles can meet.

ABSTRACT

Gentrification is a complex and controversial phenomenon that has been the subject of numerous studies, particularly in the field of urban studies. It refers to the process by which lower income, historically working-class neighborhoods are transformed into affluent neighborhoods through the influx of higher-income residents and the associated development and improvement of the physical environment. One of the most prominent examples of gentrification can be seen in the Friedrichshain neighborhood of Berlin, where this process has been taking place for several decades.

Friedrichshain is a former working-class neighborhood that has undergone significant transformations since the fall of the Berlin Wall in 1989. In the 1990s, the neighborhood became a hub for the city's creative class, attracting artists, musicians, and young professionals. With the rise in popularity of the neighborhood, property values have skyrocketed, making it increasingly difficult for long-time residents to afford to live there. As a result, many have been forced to move out, making way for a more affluent population.

The impact of gentrification in Friedrichshain has been farreaching and has had a profound effect on the social fabric of the neighborhood. One of the most noticeable impacts has been the displacement of low-income residents, who can no longer afford to live in the area due to rising rent prices. This has led to a significant shift in the demographic makeup of the neighborhood, as it becomes increasingly populated by wealthier residents.

Another impact of gentrification in Friedrichshain has been the changing cultural landscape of the neighborhood. With the influx of affluent residents, there has been a corresponding shift in the type of businesses and cultural amenities that are available. For example, the neighborhood has seen an increase in the number of upscale restaurants and cafes, while traditional working-class businesses and cultural institutions have been replaced.

One of the key drivers of gentrification in Friedrichshain has been the development of the real estate market. The influx of higher-income residents and the associated development of the physical environment has led to a significant increase in property values, which has in turn driven up rents and made it increasingly difficult for lower-income residents to afford to live in the neighborhood. This has been a major factor in the displacement of long-time residents and the transformation of Friedrichshain into a more affluent neighborhood.

In conclusion, gentrification in Friedrichshain has had a profound impact on the neighborhood and its residents. The process has led

to the displacement of low-income residents, the transformation of the cultural landscape, and the development of a more affluent population. This is the reason for designing a Public Condenser as a social catalyst, reducing the effects of gentrification in Friedrichshain. A place for people from different backgrounds to share their wealth of knowledge, experiences and creativity. This ensures that the Public Condenser serves as a breeding space for innovation and progress in the neighbourhood. Using the theme "Boundless architecture", the project is challenged to design a multiplicity concept, which might be deployed as a prototype in needy neighbourhoods.

PROBLEM STATEMENT

"Nearly three decades of division by the Mauer (the Berlin Wall) influenced the evolution of waves of gentrification and are responsible for today's very specific spatial pattern of gentrification in Berlin." (Siemer, J., and Matthews-Hunter, K. 2017). The collapse of the East Berlin economy provided the ideal conditions for gentrification projects aimed at improving living conditions in certain areas of the city, such as Friedrichshain. These projects were implemented gradually and in a concentric manner, with "pioneer" facilities (such as bars, clubs, art galleries catering to middle-class professionals and young artists) being deployed to attract new residents. However, over time, these pioneer facilities moved on to other neighborhoods, and the results of gentrification were not as positive as hoped. On the contrary, it had an effect on the social level. It led to a loss of sense of community and belonging, as well as a shift towards an increasingly homogenous population of upperclass residents. The lower and middle classes were driven out by rising costs. Additionally, the characteristic value of the area was impacted as the withdrawal of ex-pats and stakeholders led to the disappearance of the authentic look in the neighborhoods and the emergence of monotonous Plattenbau, limited facilities, and neglected public spaces.

Overall, Friedrichshain lacks multifaceted spaces where local culture can share its characters, values, and knowledge.

RESEARCH QUESTION

The search for the public condenser as a social catalyst raises the following questions:

"How can togetherness between different social groups in Friedrichshain be fostered through a public building?"

"How can boundless architecture encourage social gatherings in the building?"

"Which programs are needed for a multifaceted use of the building that brings people together?

"Which architectural qualities evoke a sense of belonging?"

DESIGN ASSIGNMENT RESULT

The Public Condenser aims to foster a sense of community among its users by catering to all socio-economic groups in Friedrichshain. The challenge is to design a building that supports this goal, achieved through housing functions that promote the "learn and create" process, such as a box-theatre, workshops, makerspace, exhibition space, and library. It also promotes the "share and meet" process, such as communal kitchen, lounge, co-working spaces, and exhibitions, as well as leisure activities like sports and outdoor spaces. A key design strategy is to provide a variety of spaces that can serve multiple functions, and to facilitate social interaction by connecting these spaces to a central collective space that serves as the "forum" of the building. This allows the Public Condenser to appeal to a wider audience.

METHOD DESCRIPTION

Information gathering about location (to understand the district):
- Collective analyses of Berlin and Friedrichshain through the
themes of City,

History, Power, People, Connection and Culture.

- Analysis of the three neighbourhoods in Friedrichshain by an excursion to Berlin
- Mapping the current facilities in the neighbourhood
- Analyse different subjects in the district, such as greenery, infrastructure, conditions, accessibility, public activity etc.

Theoretical framework (to define the concept):

- Analysing case studies with a similar theme: "boundless architecture", from which guidelines can be composed that can be used as a design tool in the process.
- Weekly TD assignments by research by design, in which positioning is defined

Design:

- Development of the main concept integrating the four themes: Prototype, multiplicity, circularity and commons.
- Weekly iteration of the design through sketches, and testing different topics.
- Use of different drawing methods both 2D drawings and 3D models to visualise the design.

After P2, the decisions made will be further elaborated and will pertain to materialization, facade design, circularity/sustainability, climate design, and building management. This will also include addressing any additional technical issues that need to be resolved.







SOCIAL MIXING

Friedrichshain consists of three neighbourhoods with various socio-groups, during the excursion, one of the observations was that these groups are mainly focused on their "own" groups or groups with similar interests. The disadvantage of this is that it can inhibit new ideas and innovations because the groups do not interact with each other. Social mixing on the contrary helps connect these groups and leads to a more inclusive community. In which each individual has the opportunity to learn from another and develop themselves. As Gehl also described, "Social mixing occurs on a spectrum from aloneness to close friendships" in which he designed a tool to encourage social mixing. They focus on this spectrum because under the right conditions, through interpersonal contact between different social groups, you can reduce prejudice (Gehl Institute, 2023).



Passive Contact

Whenever someone is in the presence of others, they are experiencing Passive Contact.

Chance Contact

A Chance Contact is when someone picks up the scarf you dropped, asks you for the time, or another non-personal interaction.

Familiar Stranger

The Familiar Stranger is someone who you recognize, but who you do not know by name. Familiar Strangers are place-based affiliations.

Friedrichshain used to be located in the east of berlin. After the fall of the berlin wall, the district become a part of the centre of Berlin.





06 | Reflection

My project Karree is a part of the graduation studio Public Building, in which Commons and multiplicity are explored as a property of a Public Condenser. In this reflection, I will explain the results of my research and design in the graduation phase. I will chronologically describe how I approached the assignment and provide details about various developments that influenced the process and the outcome.

As I wrote in my graduation plan, my interests lie in how public buildings can stimulate social interactions between different target groups in an area, in addition to fulfilling various functions. I believe that placing social functions in a building is only a small part of increasing interaction, and that the building itself can also contribute to this goal. This flexible approach to architecture is important for societal interests. Therefore, I believe that a public condenser should be regarded as a social catalyst, serving as a place of inclusion and diversity where different demographics, ethnicities, cultures, and lifestyles can meet. In my graduation project, I began with an analysis of the assignment and the context, resulting in a personal interpretation of the problem in the area and setting a general goal for the project. Through weekly research by design assignments, it was possible to explore different topics using different means, investigating how architecture could achieve the desired effect.

Goal

In short, the assignment describes Public Condenser as a place where people from different demographic backgrounds, routines, cultures, and lifestyles meet. The project location is in Friedrichshain, a neighborhood that has undergone gentrification. The goal was to improve living conditions, but gentrification had a negative effect on the social level, leading to a loss of sense of belonging, community, and a shift towards an increasingly homogenous population of residents from the upper class. The lower and middle class were displaced by rising costs. Moreover, the characteristic value of the area was compromised as the withdrawal of expats and stakeholders led to the disappearance of the authentic look of the neighborhoods and the emergence of monotonous Plattenbau, limited amenities, and neglected public spaces.

For me, the introduction of a Public Condenser in this area is to prevent further homogenization caused by gentrification and encourage social mixing, appealing to socio-economic groups in Friedrichshain. The challenge is to design a building that supports this goal by accommodating functions that promote "learning and creating" processes, such as a box theater, workshops, maker space, exhibition space, and library. It also promotes "sharing and meeting" processes, such as a common kitchen, lounge, coworking spaces, and exhibitions, as well as leisure activities


such as sports and outdoor spaces. An important design strategy is to offer a variety of spaces that can serve multiple functions and facilitate social interaction by connecting these spaces to a central collective space that serves as the "Forum" of the building. This way, the Public Condenser can appeal to a wider audience. This goes beyond simply placing different social functions in a building to attract different people. With this, I hope to ensure that the (new) residents in the area can form a community in which they can make the place their own (sense of belonging). The goal of promoting a sense of community among the people of Friedrichshain has been a dominant factor in the research and design in my graduation phase. This has been the guiding principle at each stage of both defining the program and the architectural expression, at various scales

Through the weekly research by design assignments, I came up with the theme of boundless architecture and how I can use this as a basis for my design. This includes striving for a versatile use of spaces, which leads to a more adaptable concept that can better respond to societal issues in the future. To achieve this, it is important for people to be able to open themselves up and promote different processes; "learning and creating" and "sharing and meeting". It is important to strive for curiosity in users to achieve this.



With this in mind, I researched ways in which a space can be more than just functional for certain purposes, with boundless architecture being central to this. After historical research, I came across the Mietskaserne, which shaped the culture of Berlin at the time. The principle of this was that all different social classes (rich and poor) lived together under one roof, with a communal courtyard. Despite the bad conditions (neglected) in most of these buildings, the residents enjoyed living there because of the social interactions they had. In current Friedrichshain, this is no longer the case, partly due to gentrification. But this way of thinking describes what I believe about a Public Condenser and its function. Not so much the typology of the Mietskaserne, but the idea that different social classes are not separated from each other but are instead connected through a collective space.

This led me to the Forum principle, where a central point is designed with spaces around it. The Forum creates a space for people to connect, listen to each other, understand, or even empathize with each other. The open view of each other will promote a sense of togetherness. To promote meetings between different social groups, it is important to offer a variety of spaces that can serve multiple functions. While compiling my program, I mainly looked at functions that can take place in an informal way. Since the formal way requires specific spaces, the informal way is easy to merge into a large space. This blurs the boundaries and creates a space where different groups interact with each other and inspire each other.



Function of the Forum

Origin of Karree


Friedrischain is divided into three different neighborhoods, each with its own character. The challenge here was how to bring these three neighborhoods together in some way so that the Public Condenser becomes a place for everyone in the district. To express my idea in a specific location, I looked mainly at centrally located places that are easily accessible and offer the possibility to connect the neighborhoods with each other. This led me to the location of Wriezener Karree, located on an industrial site that blocks the connection between the neighborhoods due to mainly vacant buildings and industrial function. The challenge here was primarily to attract residents of Andreasviertel, where social functions are minimally present. An important barrier on this side is the park without sight lines to the project location and the fast traffic that separates the two neighborhoods. On the other hand, the challenge is to attract residents of Weberwiese, who are largely blocked by the industrial character of the project location. I realized that the Forum in my design had to be the eye-catcher, and to do it proper, the architecture on the outside had to be in contrast. The building should attract attention without revealing too much and blend into the surroundings. While the architecture inside forms a completely different world that is isolated from the

rapid changes of the outside world, a place that puts everything on hold and creates calmness. As a materialization, I chose to work with one material as much as possible, which is expressed in different ways: wood. This not only generates curiosity but also radiates unity with its own identity.

Step back

After the P2 presentation, I decided to take a step back and evaluate whether the Forum, which is the main element in my design, was being fully utilized and how I could implement it differently in the design. In this phase, the Forum was a space on its own, connected to the other spaces, but lacking a clear connection. Although the Forum was the central focus, there was a barrier between the spaces and the Forum. In the weeks following my P2 presentation, I focused on how to break down this barrier and make the Forum an integral part of the architecture. Eventually, I came up with the idea of viewing the Forum as a kind of canyon that defines the spaces, allowing users to sit in different places and heights. The canyon forms a world of its own within the building and is the connecting factor with the other spaces. By varying the size of the steps, different zones can be created to organize the collective space without physical elements. The Forum thus functions not only as a staircase, but also has multiple meanings that will stimulate social interactions between groups. Looking back, this further step strengthened my concept, which was necessary. However, I did not realize that the new design with the Forum brought about much more complexity, resulting in more time pressure than usual in the last few weeks.








Design approach after P2

To sum up, by combining all facets of the design process, I arrived at my design for a Public Condenser that counteracts the homogeneous gentrification in Friedrichshain and encourages social interaction and mingling. The design introduces a stimulating intermediate space, described as an Forum, which serves as a connecting factor both in terms of architecture and users. The balance between functions, open and active public spaces, transforms the area into a vibrant community where people become part of the city. This research serves as a prototype and offers the possibility of applying the idea to different locations. It serves as a basis for future design by exploring the multiple use of space with various


themes. Moreover, the flexible approach to spatial qualities leads to a more adaptable concept that can better respond to the rapidly changing and unpredictable future.





Principle Mietskaserne diagram





