Problem Statement

The problem described in the section aboves show that the Tegang danwei compound regeneration agenda in current municipality means of planning and governance creating two main conflicts on the local community level: the cultural conflict between Tegang dynamicbut vulerable post-communism Danwei life and gentrified community life, intensifing social segregation; the political conflict between local community residents' consciousness of citizenship via informalurbanism spatial practice and external actors's administration strenthening on the local community governance, disrupting the community-level democracy potentials.
