The posed problem,		Madrid as a caring adoptive entity of its human and non-human inhabitants. The concept of critical care is an activator in the relationship between human and non-human actors, exploring innovative ways in which they can support each other. This can then inform the formation of creative forms of collective engagement in the common		

	spaces of a city, eventually strengthening citizen responsibility and integration between different social groups. Maybe if our spatial systems could accommodate different forms of maintenance involving collective engagement there would be more equitable common spaces and activities in the city.
research questions and	What if notions of critical care could be addressed in the formation of equitable common spatial infrastructures? How can these accommodate performative acts of maintenance as a form of collective responsibility?
design assignment in which these result.	The design proposal aims to introduce a network of educational and communal facilities within the neighbourhood mentioned. This system of hybrid structures would be initiated with the support of district and municipal institutions, active NGOs in the area, and engaged residents. The first intervention serves as the initial step in expanding the proposed network. This would take the form of an educational atelier where local residents can come together to learn from skilled local craftsmen about working with various construction materials and maintaining them. The goal is to establish a foundation of knowledge and skills that will empower the community to self-construct future neighbourhood centres, contributing to the growth of the network of caring structures. The proposed buildings are designed to remain open to public spaces, as well as to natural elements and phenomena, fostering a harmonious environment for both human and non-human processes. In addition to the workshop, the main communal centre will house a variety of functions to keep it active throughout

the day, energizing the surrounding
public areas. The building will be taken
care of one or two residents who
commit to the responsibility in exchange
for housing within the same complex.

Process

Method description

The topic of care extends over multiple scales and networks. To get a grip on the complexity involved in this in Madrid it is essential for this research to study the historiography of care in its specific context. Therefore, an actor network analysis as described by Bruno Latour¹ and John Law² will be performed in which the relations between physical and non-physical, human and non-human are investigated in the context of the changing institutions, places or elements of care in Madrid. In the context of my research the non-human actors are spaces where actions take place, materials, objects and animals. They can be further arranged in a **matrix** of care elements to ease comparison, deepening and extension. (see Figure 6)

Reflection

 What is the relation between your graduation (project) topic, the studio topic (if applicable), your master track (A,U,BT,LA,MBE), and your master programme (MSc AUBS)?

My work focuses on developing equitable communal structures for implementation in urban residential neighbourhoods, specifically Numancia in Puente de Vallecas, Madrid. The project aligns with the goals of the Architectural Design Crossovers studio, exploring urban commons while addressing the repair of social frameworks alongside material and physical ones.

The project aims to bridge disciplines within the built environment, spanning urban planning, public spaces, buildings, technical details, materials, and living beings. By proposing a system that both draws from and influences these scales, it strives for a holistic approach. I believe that carefully considering the diverse factors shaping urban life can lead to more thoughtful and integrated design interventions. For me, care is central to the architectural design process. It involves taking the time to observe, understand, and respond to external stimuli, enabling deliberate, empathetic, and considerate reactions. This approach seeks to benefit all affected actors—human and non-human alike—by addressing their interconnected needs with sensitivity and thoughtfulness.

2. What is the relevance of your graduation work in the larger social, professional and scientific framework.

Through this research, I aim to contribute to a broader understanding of urban care by integrating social, material, economic, and ecological perspectives. By challenging traditional notions of care as a hierarchical power structure, my work explores more equitable and empathetic approaches to designing and interacting with shared spaces. This shift seeks to foster communal practices that bridge social divides, promote collective responsibility, and empower communities to engage more deeply with their environments.

The project draws on theories of repair, maintenance, and critical care in architecture to propose a rebalancing of agency—encouraging humans to reconnect with the non-human realm and create more inclusive urban ecosystems. Grounded in a thorough theoretical framework, the research further combines case study analysis with a site-specific historical and material investigation of, both Madrid, and Numancia, a peripheral residential neighbourhood in the district of Puente de Vallecas. By envisioning scenarios that challenge current paradigms, this work aims to inspire professionals, researchers, and communities to rethink urban design as a tool for equitable and sustainable transformation, addressing both human and non-human needs in contemporary cities.
