Contributors

Kate Booth, PhD, is a human geographer at the University of Tasmania, specializing in the field of critical insurance studies. She is particularly interested in the economic and social geographies of insurance in a changing climate, and implications for inequality and inequity. Kate has also worked on projects looking at sense of place, and the role of arts and culture in urban regeneration. Her work is published in journals such as *Progress in Human Geography*, *Environment and Planning A: Economy and Space*, *Environment and Planning E: Nature and Space*, *Urban Studies*, and *Qualitative Inquiry*.

Eliza de Vet's, PhD, research interests include individual and household experiences of weather, climate (change), and natural hazard-related disasters, with particular interest in mitigation and adaptation strategies. Based at the University of Wollongong, her key publications relate to everyday weather-related cultural practices and environmentally sustainable thermal comfort strategies. Recently, her research has extended to the role of home and content insurance in household disaster resilience, publishing on building regulations and under-insurance, insurance as an unmitigated disaster, and insurance as essential tool for long-term household recovery.

Rebecca Elliot, PhD, is an Assistant Professor of Sociology at the London School of Economics. Her research examines the intersections of environmental change and economic life, as they appear across public policy, administrative institutions, and everyday practice. She is the author of *Underwater: Loss, Flood Insurance, and the Moral Economy of Climate Change in the United States* published in 2021.

Dr. Christine Eriksen, PhD, University of Wollongong, gained international research recognition by bringing human geography, social justice, and natural hazards into dialogue. With a particular interest in social dimensions of disasters, her widely published work examines social vulnerability and risk adaptation in the context of environmental history, cultural norms, and political agendas. She is the author of two books:

Alliances in the Anthropocene: Fire, Plants and People (2020) and *Gender and Wildfire: Landscapes of Uncertainty* (2014). Dr. Eriksen joined the Center for Security Studies at ETH Zürich, Switzerland in August 2020. Prior to that, she worked for 13 years as an academic at the University of Wollongong, Australia. Her work has focused on case studies in multiple countries and continents, including Australia, North America, Europe, and Africa.

Shaun French, PhD, is an Associate Professor in Economic Geography at the University of Nottingham. He focuses on the geographies of economic practice and knowledge, specifically financial services and money, socially responsible investment, and financial centres. As part of the University's Rights Lab, he is developing new work on debt, vulnerability, and anti-money laundering.

Kevin Grove, PhD, is an Associate Professor of Geography at Florida International University. His research explores the politics of disaster management and resilience in the Caribbean and North American cities. His work has been published in a variety of academic journals, including the *Annals of the American Association of Geographers*, *Environment and Planning D: Society and Space*, *Progress in Human Geography*, and *Security Dialogue*, and he is the author most recently of *Resilience* (Routledge) and co-editor (along with David Chandler and Stephanie Wakefield) of *Resilience in the Anthropocene: Governance and Politics at the End of the World* (Routledge).

Olli Hasu is a doctoral student at Tampere University, Finland. His work focuses on climate change, the infrastructure character of new information technologies, and index insurance.

Mark Kammerbauer's, PhD, field of expertise covers risk and resilience in the built environment under consideration of socio-cultural issues, governance, and vulnerability. Over the past 15 years, he has researched cases of disaster recovery and reconstruction in the United States, Germany, Australia, and the Philippines. Mark held research and teaching positions at international higher learning institutions, including the University of Queensland School of Geography, Planning and Environmental Management, Lund University Centre for Sustainability Studies, Tulane University Center for Bioenvironmental Research, and Technische Universität München. Ken Klein, PhD, is the Lewis and Hermione Brown Professor of Law at California Western School of Law. A wildfire survivor himself, he teaches and publishes on insurance issues arising in the wake of natural disasters. He is a consumer representative to the National Association of Insurance

Commissioners (NAIC) and has presented on issues of insurance and wildfire to the NAIC, the Federal Home Finance Administration, and to HopeNow, an organization of mortgage lenders/servicers. For his thousands of hours of volunteer work on-site in the wake of natural disasters, he has been awarded the State Bar of California's highest award for pro bono legal services.

Turo-Kimmo Lehtonen, PhD, is a Professor of Sociology at Tampere University, Finland. His present work centres on two different areas; one of which is insurance and the management of uncertainty, and the other the role of waste in contemporary life. In addition, Lehtonen has written extensively on social theory. His recent work includes papers in the journals *Political Theory*, *Cultural Studies*, *Distinktion*, *Theory, Culture & Society*, *Valuation Studies*, and *Economy and Society*.

Chloe Lucas, PhD, is a human geographer at the University of Tasmania. A communications specialist, she began her career making documentaries about science and landscape history for the BBC. Chloe's research explores the values and experiences underlying different social responses to climate change, and identifies pathways to more empathetic and inclusive climate conversations. Her recent work focusses on how communication and cultural context drives social adaptation to extreme weather events, and can be found in journals including *Climatic Change*, *Environment and Planning E: Nature and Space*, *Geographical Research*, and *WIRES Climate Change*.

Liz McFall, PhD, is the Director of Data Civics and Chancellor's Fellow based in the Edinburgh Futures Institute and Sociology at the University of Edinburgh. She co-edited *Markets and the Arts of Attachment* (2017), wrote *Devising Consumption: Cultural Economies of Insurance, Credit and Spending* (2014) and *Advertising: A Cultural Economy* (2004) and edits the *Journal of Cultural Economy*. She is co-founder of AWED, a collective that make films and installations exploring the orchestration of civic sentiments and data techniques, most recently *Closes and Opens: A History of Edinburgh's Futures* – available on YouTube.

Scott McKinnon, PhD, is an oral historian and geographer at the Australian Centre for Culture, Environment, Society and Space (ACCESS), University of Wollongong. His research explores the social dimensions of disaster, including processes of disaster commemoration, and the impacts of disaster on marginalized social groups. He is co-editor (with Margaret Cook) of *Disasters in Australia and New Zealand: Historical Approaches to Understanding Catastrophe* (published 2020). Scott has also published extensively on histories and geographies of sexuality, including *Gay Men at the Movies: Cinema, Memory and the History of a Gay Male Community* (2016).

Pat O'Malley, PhD, is a Distinguished Honorary Professor in the School of Sociology at the Australian National University and an Adjunct Research Professor in Sociology at Carleton University in Canada. Previously, he was Professorial Research Fellow in Law at the University of Sydney. Most research over the past 25 years has focused on risk as a form of governance in criminal and civil justice, disaster management, and insurance. Recent research into insurance has focused on the role of the insurance industry in promoting and enacting risk-based fire prevention regimes in urban settings.

Nick Osbaldiston, PhD, is a Senior Lecturer in Sociology at James Cook University, Australia. His research focusses on three areas: internal migration, adaptation to environmental risks, and coastal research. He has recently published the monograph *Towards a Sociology of the Coast* (published 2018) and prior to that *Seeking Authenticity in Place, Culture, and the Self* (published 2012).

Lauren Rickards, PhD, is a Professor in the Centre for Urban Research at RMIT University, Melbourne, where she leads the Urban Futures Enabling Capability Platform and the Climate Change Transformations research program. Lauren is a lead author with the forthcoming IPCC report on Impacts, Adaptation and Vulnerability.

Minna Ruckenstein, PhD, is an Associate Professor at the Centre for Consumer Society Research at University of Helsinki, Finland. She leads an interdisciplinary research group, and is currently directing two large research projects, one focusing on algorithmic culture and the other on rehumanising automated decision-making.

Maiju Tanninen, PhD, is a doctoral researcher at University of Helsinki and Tampere University. In her ongoing PhD research, she studies the (new) datafication of life insurance markets, focusing on both industry practices and consumers' everyday experiences with the emerging technologies.

Zac Taylor, PhD, is a Research Fellow in the Faculty of Architecture and the Built Environment at Delft University of Technology. They research urban climate risk governance within the financial system and across three contexts (South Florida, Singapore, and the Netherlands).
