Young Adults with Intellectual Disabilities (YAIDD)

Family members of YAIDD have reported that:

- Transition period is as stressful as the time of diagnosis
- Disrupted development and the missing knowledge of independent living skills delays transition
- More guidance is necessary when choosing transitional development plans





Guiding principles and outcomes of the project





Independence

- Ability to perform own self-care and domestic tasks
- Skills of decision making, problem solving an selfadvocacy


Social participation

- Social skills training programs focused on gestures, vocalization and quality of interactions
- Forming connections through jobs, hobbies and volunteering.


Wellbeing

- Education and behavioral interventions that promote healthy habits.
- Optimizing environment to the controlled level of stimuli to minimize psychological distress.











6 Design Principles



1 - LEGIBILITY AND WAYFINDING

The process of organizing environmental information to help users find their way. To avoid user's frustration, designers must consider five predominate elements of legibility: paths, edges, districts, nodes, and landmarks (Pearson et al., 2016, p. 14).



4 - PRIVACY AND CHOICE

Neurodiverse individuals should be given an opportunity to choose the desired level of privacy: solitude, intimacy, anonymity, or reserve. (Pearson et al., 2016, p. 25).



2 - PROSPECT AND REFUGE

Prospect refers to the ability to survey the environment and have an uninterrupted view of the space before entering it. Refuge is the opportunity to hide inside the space or take necessary escape routes. When carefully designed, spaces that allow prospect and refuge encourage social interactions and active participation.



5 - DESIGN FOR SENSES

On one hand, sensory information can help YAIDD understand their environment, but it can also contribute to increased levels of stress one can get from an overloaded stimuli. For this project, light, color, noise and touch are taken into consideration. In addition, the benefits of Snoezle-rooms are addressed.



3 - TERRITORIALITY AND CONTROL

Regardless of the size of the territory, individuals with IDD wish to have control over an area of space.



6 - DESIGN FOR ROUTINE

Sequencing of activities and spaces could promote routine for YAIDD. Compartmentalization of spaces for specific activities could be used for associating spaces with particular tasks.






LAAKKWARTIER: Site selection criteria


