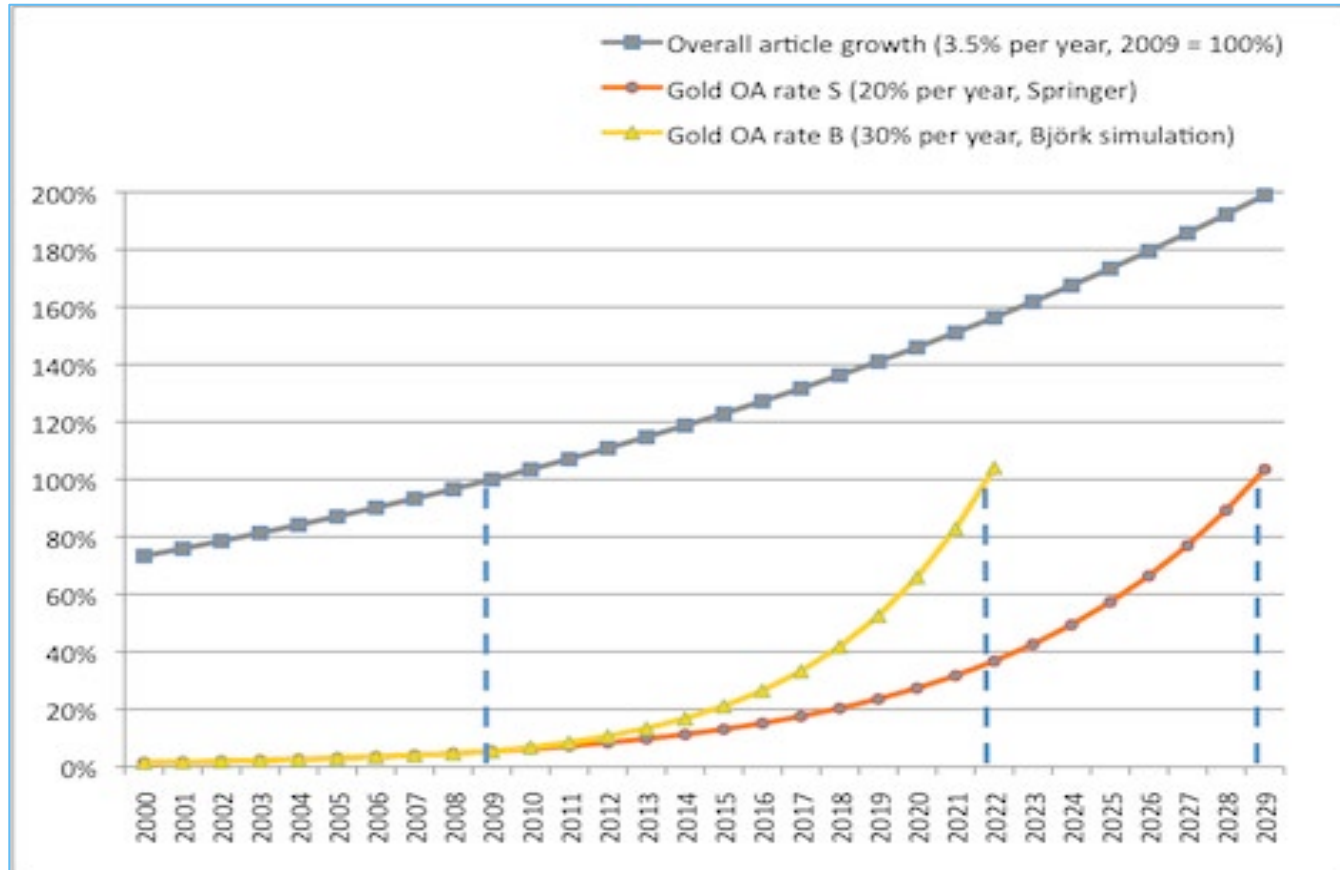
Bottlenecks transition OA

- Traditional lucrative business model subscriptions alive
- Exclusive transfer of rights hinders Open Access and reuse of publications
- Impact and citations for scientists still crucial, not the way of dissemination
- Any changes in the interests of stakeholders?

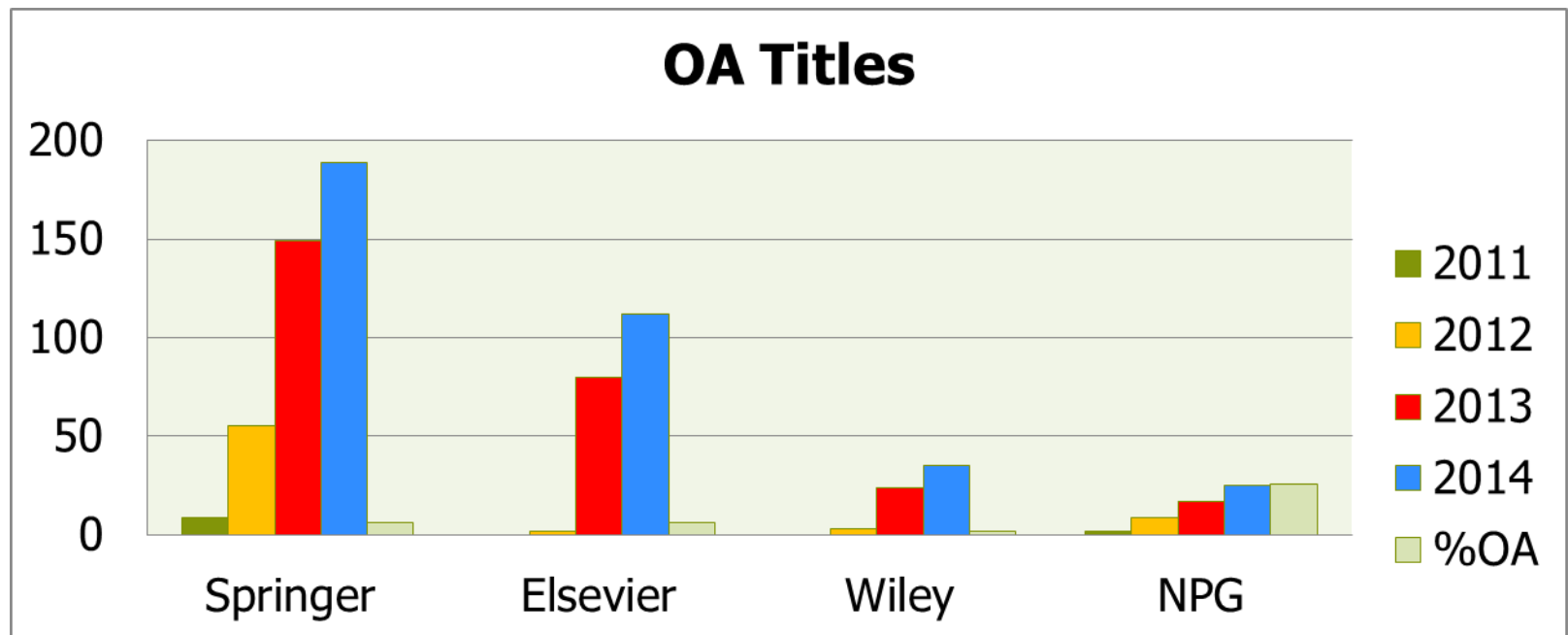

Chemical Science moves to Gold Open Access

Chemical Science, launched in 2010, is set to become the world's first high-quality Open Access chemistry journal.

From the first issue in January 2015, our flagship journal will move to Gold Open Access. All content published from that date will be free to every reader.

Plus, unlike other Gold Open Access journals, we will waive all Article Processing Charges (APCs) for at least two years. So it will be free for authors too.

Danish minister announces ambitious Open Access targets

Denmark has joined a long line of European countries and announced a national strategy for Open Access. It follows in the footsteps of the European Commission and recommends Green Open Access as the main route.

Danish Minister is strong support of Open Access

Earlier this year - at the ESOF conference in Copenhagen - Sofie Carsten Nielsen, Denmark's Minister of Higher Education and Science announced the long awaited Danish Open Access strategy. In her presentation she underlined her support to Open Access by pointing out the Open Access started as a movement but today is an integral part of the overall framework for research. "We need to push this agenda forward" stated Sofie Carsten Nielsen.



Ambitious goals

What is remarkable in the Danish strategy for Open Access are the ambitious goals to reach Open Access to 80 % of all publically funded peer reviewed articles in 2017 and concluding this with 100 % in 2022.

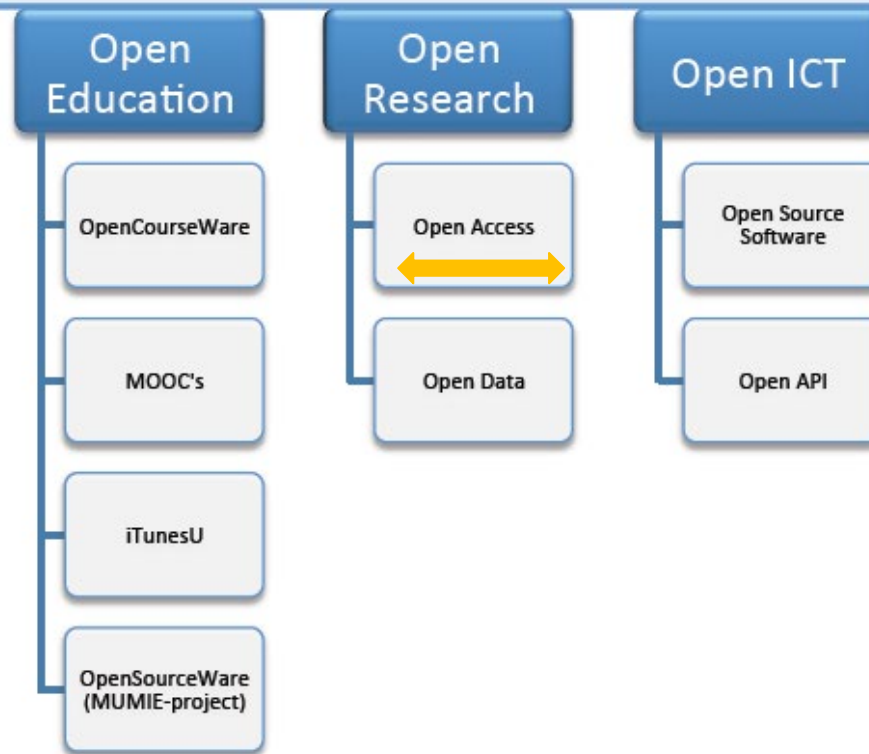

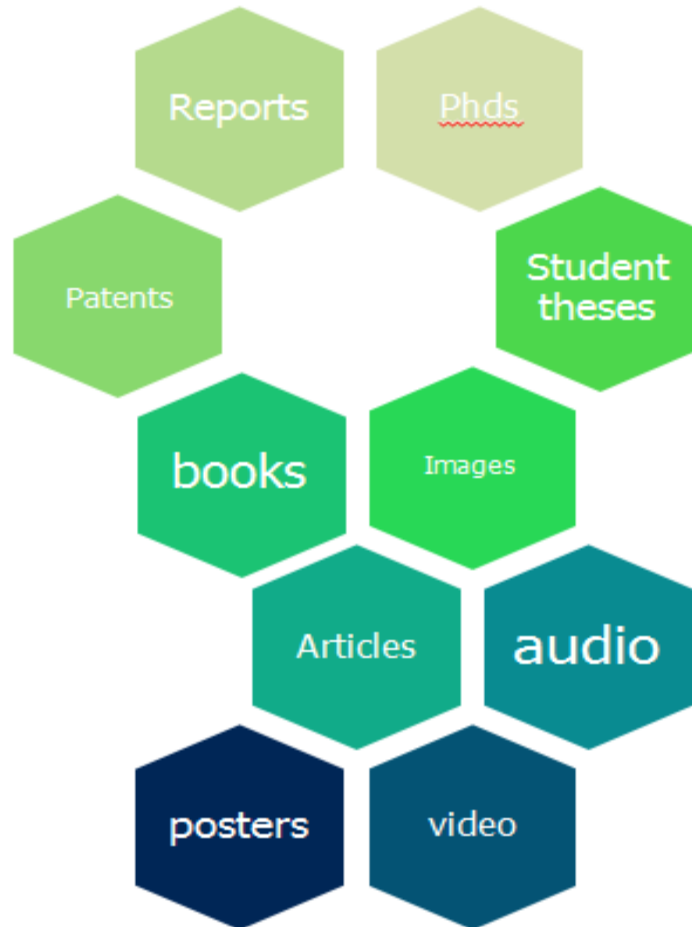
Evolution of publisher's policies, 2004-2012

TU Delft Library and IOS Press sign agreement on Open Access books Delft authors

JANUARY 21, 2014

TU Delft Library and IOS Press have signed an agreement to publish at least ten Open Access (OA) books - as ebooks – by authors affiliated with TU Delft. Both parties hope to stimulate the use of OA within all TU Delft departments.

“When talking about scientific publishing, one can no longer exclude Open Access from the equation. TU Delft prefers OA because titles are widely available directly upon publication without restrictions,” says Just de Leeuwe of TU Delft University. TU Delft has been supporting the use of Open Access since 2004. The Library does its own research into the effectiveness of OA and manages several repositories and the [TU Delft OA fund](#).

Since 2010 IOS Press has increasingly been publishing OA books and journals. The publishing company has a special relationship with TU Delft: in 2005 all activities of Delft University Press were taken over by IOS Press. Publications affiliated with TU Delft are now published under the Delft University Press imprint.

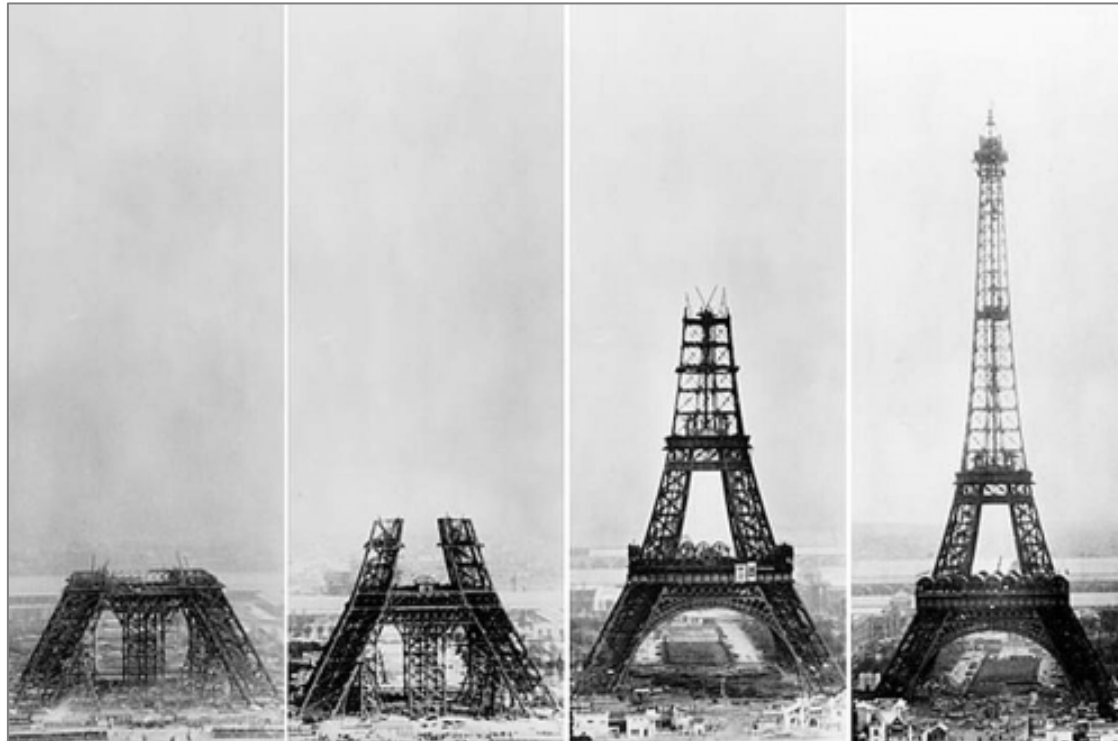

A new report from media and publishing intelligence firm Simba Information indicates that a global campaign to increase open access to scientific research has created a fast-growing revenue stream for scientific, technical and medical journal publishers.

The debate about how free is free (costs) and how open is open (copyrights) are ongoing. However open access is already having a bigger impact in terms of publishing output. By some estimates, it already represents 10 per cent to 20 per cent of all research articles published.

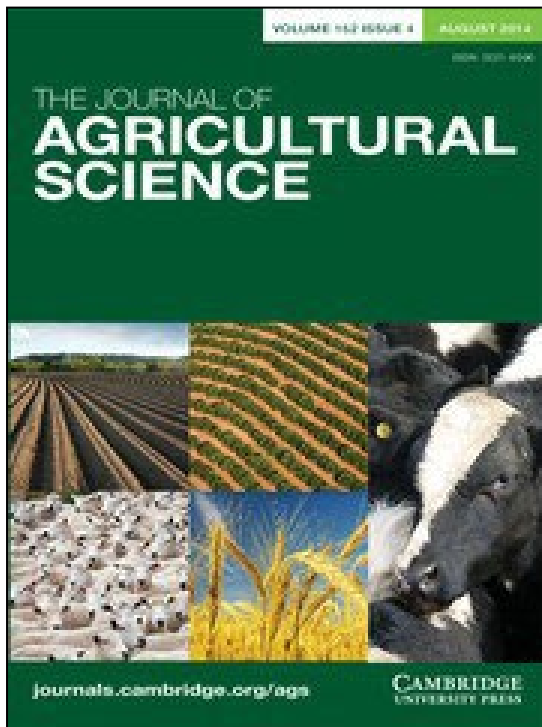
Cybercriminals



Hijackers make money by stealing the identities of legitimate journals and collecting the article processing charges on the papers that are submitted to journals

Cybercriminals have cheated thousands of professors and Ph.D. scholars mostly from developing countries and those who were in the urgent need of publishing their articles in journals that are covered by the Journal Citation Report
