# Social Innovation – Learning from Multinational Collaboration

### 16th - 17th November 2022

Online Conference

This conference brings together the <u>Trans-Atlantic Platform</u> Social Innovation grant holders and their cooperation partners (including stakeholders), other Social Innovation experts, and Trans-Atlantic Platform (T-AP) <u>funding agency representatives</u> in an online event.

#### The conference aims to

- explore outcomes of the 10 T-AP Social Innovation projects funded,
- share knowledge on how to implement innovative research concepts to meet social needs,
- develop a common understanding of pivotal issues in collaborative Social Innovation research,
- consider the impact and sustainability of Social Innovation projects in the humanities and social sciences,
- make recommendations specifically geared to future multinational Social Innovation research demands.
- give feedback for funding agencies that could help to improve the process of future T-AP calls.

The multinational and trans-Atlantic projects funded under the T-AP Social Innovation call comprise research teams from Brazil, Canada, Germany, Finland, France, the Netherlands, Poland, and the United Kingdom. Each project comprises researchers from a minimum of three countries with at least one partner from the Americas and at least one partner from Europe. These joint research teams deal with conceptual issues of international collaborative social innovation and are involved in the development of adequate new social and historical research methods. They tackle social innovation processes in a variety of settings which include multinational companies and activist networks, pharmaceutical research and production against the background of patient needs, plastic production and recycling management, the museum sector, social housing, education of marginalized indigenous and immigrant children, everyday life of marginalized youth, indigenous cultural communities or social structures arising from racism.

The T-AP Social Innovation projects add both to an understanding of Social Innovation while delivering social innovation(s) through new research. The focus of the conference is on what Social Innovation research can learn from multinational collaboration by

- comparing social challenges faced on both sides of the Atlantic,
- learning from the experiences of multisectoral collaboration for social innovation practiced on both sides of the Atlantic,







- applying and adapting approaches from one locale to another,
- generalizing and/or scaling-up of local experiences.

The 10 T-AP projects will report on how they have contributed to the understanding of Social Innovation and created social innovation(s) through new research. In addition, the conference aims to develop a common understanding of pivotal issues in collaborative Social Innovation research. To meet the latter aim, the focus of the presentations will be on four topical questions:

- What is the upscaling potential of the social innovation, and can it also apply to other fields and circumstances?
- What were the specific context conditions that led to the social innovation, and how did the process from some creative act to a Social Innovation process unfold?
- What role did entrepreneurs (social, political, economic, cultural) play in bringing about the social Innovation?
- What was the particular 'social' aspect of the innovations and what sets it apart from other kinds of innovations?

Furthermore, conference participants will have the opportunity to discuss these questions in special group work sessions on the basis of their learnings. External Social Innovation experts will moderate these group discussions and summarize learnings and recommendations. Final recommendations will be developed and recorded in a conference report on the basis of these group discussions.

The question of how to achieve broad impact and sustainability through multinational research collaboration will be addressed throughout the conference. Potential implications for future innovative international research collaboration in the social sciences and humanities will also be explored. Last but not least, participants will be urged to make recommendations for improving future T-AP calls.

Despite its online format the conference aims to facilitate as much deliberation as possible between more than one hundred researchers, stakeholders and funding agencies' representatives.
