The posed problem,	The Hague, Netherlands The Zuid-West district in The Hague has deficient socialisation patterns despite relative high amount of public spaces. As a modernist paradigm, the Zuid-West neighbourhood is characterised by rigid spatial forms, repetitive and elongated buildings blocks standing in wide open spaces. An area "dominated by the wonderful means of simple repetition" ² as its designers Willem Marinus Dudok explains. The public space consists of parks, sport fields, theatres and shopping area. A large park, called the Green Cross, is situated in the centre of the district. Despite the high level of public affordances, the area fails to accomplish dense and cohesive social patterns. Terms such as "social segregation" and "polarisation" are used by researchers to describe the district ³ , and it is exposed to higher insecurity and poverty then the surrounding areas ⁴ . Here, the public facilities do not yield cohesive social patterns.			

research questions and	Why are the socialisation patterns in the Zuid-West deficient despite high amount of public spaces? How can we create more cohesive space, both socially and spatially?
design assignment in which these result.	The assignment is to create more socially and spatially cohesive space by reorganizing the existing public facilities and promoting better connection between these facilities and the inhabitants of The Hague.

Process

Method description

Architecture has the advantage of being a relatively methodology-agnostic discipline, as Raymond Lucas argues in *Research Methods for Architecture*⁵. Our profession has indeed developed several sets of practical and pragmatic activities in response to the wide range of problems it is confronted to. However, we should not assume that each of these methodologies is benign or neural. From the collection of raw data, its organisation, reduction, codification, synthesis and presentation, the research reveals both unseen realities and new hidden potentials. The analytical tools employed for this thesis include the mapping method and the assemblage. Mapping and assemblage are the most appropriate methods because they allow for the superimposition of spatial and social elements, quantitative and qualitative information into a larger image.
